WE, AND ON OUR CHILD'S BEHALF, DO HEREBY FOR AND ON BEHALF OF OURSELVES AND OUR HEIRS AND LEGAL REPRESENTATIVES AND OUR CHILD RELEASE AND FOREVER DISCHARGE THE DANVERS GIRLS TRAVEL BASKETBALL, ITS OFFICERS AND REPRESENTATIVES, AND ANY OTHER ENTITIES OR REPRESENTATIVES OF SUCH ENTITIES SPONSORING OR CONTRIBUTING TO THE PROGRAM FROM ANY AND ALL CLAIMS, DEMANDS AND INJURIES HOWSOEVER ARISING, WHETHER CAUSED BY THE NEGLIGENCE OR INTENTIONAL ACTS OF THE DANVERS GIRLS TRAVEL BASKETBALL PROGRAM AND ITS REPRESENTATIVES AND ANY OTHER ENTITIES OR REPRESENTATIVES OF SUCH ENTITIES SPONSORING OR CONTRIBUTING TO THE PROGRAM, OR BY THIRD PARTIES, WHICH MAY BE IN A WAY RELATED TO MY CHILD'S ACTIVITIES DURING THE PROGRAM AND ANY PERIOD TRAVELING TO OR FROM THE PROGRAM DESCRIBED AND ALL SUCH CLAIMS ARE HEREBY **WAIVED & RELEASED**, AND WE ON BEHALF OF OUR CHILD, COVENANT NOT TO SUE THEREFOR. THE PARENT(S) OR GUARDIAN(S) BY THE SIGNING BELOW HEREBY AGREES TO INDEMNIFY AND HOLD HARMLESS THE DANVERS GIRLS TRAVEL BASKETBALL PROGRAM AND ITS REPRESENTATIVES, AND ANY OTHER ENTITIES SPONSORING OR CONTRIBUTING TO THE PROGRAM FROM ANY LIABILITY WHICH THEY MAY INCUR TO THE CHILD (ENTRANT), HOWSOEVER ARISING AND WHETHER CAUSED BY THE NEGLIGENCE OR INTENTIONAL ACTS OF THE DANVERS GIRLS TRAVEL BASKETBALL PROGRAM, OR ANY OTHER ENTITIES SPONSORING OR CONTRIBUTING TO THE PROGRAM OR THIRD PARTIES.
